- (in case of college) to (a) State Coordinator NSS, Commissionerate of College Education, Shiksha Sankul, J.L.N. Marg, Jaipur, (b) State NSS Officer, State NSS Cell, Education Group 4-A, Secretariat, Jaipur and (c) Regional Director, Regional Directorate of NSS – Jaipur, 5, Arvind Park, Tonk Road, Jaipur.

All SFUs should furnish the reports including Monthly Progress Report on prescribed pro-forma from time to time. Proper accounts of expenditure may be maintained and submitted to the State Coordinator NSS, Commissionerate of College Education Rajasthan, State NSS Officer and Regional Director office every year. Institutions are also advised to constitute mandatory NSS Advisory committee (in case of university refer pg. 62 of NSS manual and in case of college, refer pg. 64 of NSS manual) and convene the yearly meeting as per mentioned in NSS manual.

It is also Mandatory for Institutions


1. To create dedicated email id of your institution for NSS related communication.
2. to create official social media accounts of NSS unit on Facebook, Twitter, Instagram and post NSS activities on them by using official handles of NSS Rajasthan and NSS India.
3. Submit the NSS volunteer and NSS PO information in the enclosed excel sheet to this office.
4. to get registered on Mera Yuva Bharat portal (<https://mybharat.gov.in/>) as Knowledge Institution within a week of this order. The registration guidelines and Registration Proforma is enclosed herewith.
5. To onboard / register NSS volunteers on Mera Yuva Bharat portal (<https://mybharat.gov.in/>) as youth and join your institution's Knowledge Institute within a week. Other than NSS volunteers may also be encourage to get onboard for future beneficial Academic / National / International programs.
6. To create Events of all NSS Activities on MY Bharat Portal and upload photographs.
7. To create and fulfill at least 5 ELP (Experiential Learning Program) on suitable topics or according to course curriculum i.e. Cyber Security, Agriculture, Mass Communication, Latest Technologies in various field and other which is beneficial for students. This ELP is open for all students.

If any serious discrepancies are found, the NSS unit will not only be revoked but will also be blacklisted for future allotments under both the Self-Financed and Grant-In-Aid categories.
